| Standard #1: | Physical therapist assistants shall respect the inherent dignity, and rights, of all individuals. |
| Standard #2: | Physical therapist assistants shall be trustworthy and compassionate in addressing the rights and needs of patients. |
| Standard #3: | Physical therapist assistants shall make sound decisions in collaboration with the physical therapist and within the boundaries established by laws and regulations. |
| Standard #4: | Physical therapist assistants shall demonstrate integrity in their relationships with patients, families, colleagues, students, other health care providers, employers, payers, and the public. |
| Standard #5: | Physical therapist assistants shall fulfill their legal and ethical obligations. |
| Standard #6: | Physical therapist assistants shall enhance their competence through the lifelong acquisition and refinement of knowledge, skills, and abilities. |
| Standard #7: | Physical therapist assistants shall support organizational behaviors and business practices that benefit patients and society. |
| Standard #8: | Physical therapist assistants shall participate in efforts to meet the health needs of people locally, nationally, or globally. |
