#### **Update on Enrollment**

As of July 23, 2025, semester credit hours for credit and dual credit are up by 14.73% for Summer I and for Summer II up 7%. The actual percentage of goal achieved for Summer is 110% headcount, 106% contact hours and 113% of semester credit hours. Fall 2025 semester credit hours are up by 2% and has achieved 66% of headcount, 69% of contact hours, and 69% of semester credit hour goals. Continuing Education has achieved 63% of contact hours for quarter 4.

# **Finance and Operations**

#### June 2025 Financial Statement

Vice President Teresa Thomas presented the June 2025 Financial Statements to the Board for approval. There were no budget amendments for the month. Source of funds percentages ending June 2025 were Academic student income 95.62%, Continuing Education 92.78%, Local appropriations 117%, State funds 77%, with 87% of budget earned.

The 2025 total guaranteed funding is \$16.6 million with payments in October, February, and June with a settle-up payment.

Disbursement of funds ending June 2025 for other expenditures increased by \$4.8 million compared to the same time in 2024. When you compare sources and disbursements for Educational and General Fund, and Grants the revenue is higher by \$1.1 million from June 2024. The actual sources of funds for Education and General Fund as of June 2025 for FY 2025 are \$45 million with total expenses of \$42 million. The total cash & cash equivalents as of June 30, 2025, is \$27.3 million with average monthly expenditure budget covered by available cash at 3.64% and overall average of 4%

The motion to approve June 2025 Financial Statements were made by Trustee John Paul Ross and second by Trustee A.L. Atkeisson. All were in favor, none opposed

# **District President's Report**

Dr. Kevin Fegan presented to the Board accomplishments for 2024-2025 on Enrollment progress, Student Success Outcomes, Registrar, Admissions, Athletics, Bulldog Life, Bookstore, Dining Services, Financial Aid, Grants Management Office, Institutional Effectiveness and Research, Marketing, Trio Support Services, Academic Affairs, CTE, Student achievements, IT, Physical Plant, Police Department, Professional Development, Foundation, Finance, Albritton Bldg. and RV Tech program.

The starting state appropriations were at \$11 million and this year the state appropriations totaled \$17 million due to more students completing outcomes. The College has averaged over \$3 million in grants.

Dr. Fegan presented to the Board the monthly calendar with events scheduled for August. He shared detailed information with the Board on Senate Bill 17, Senate Bill 37, and Senate Bill 2615 and what impact it could have for the College. After the meeting, the information is available for Board Members in their BoardEffect platform for reviewing.
