Chairman Judson asked for a motion to approve the Consent Calendar.

## **Board Recognition**

We talk about Bulldog Pride and importance of Navarro College history, tradition, legacy, and values. For any institution the vision, mission and purpose are only as successful as the people and the heart of the organization. Navarro College has been blessed for 76 years to have outstanding individuals who have modeled the values, vision, mission, and purpose Navarro College were founded on. Some of the individuals who contributed to the legacy and are legacies themselves. We have the privilege to honor six of those individuals tonight which are the longest serving Navarro College employees. Chairman Judson and Trustees I would like to recognize these individuals. Dr. Fegan acknowledged and presented crystal trophies to Dr. Lary Reed, Mr. Dan Nesmith, Dr. Kenneth Martin, Dr. Thomas Vance, Dr. Tommy Springer, and Mr. Mark Dillman that have served the college for over 40 years and mentioned that we have opportunities because of these individuals.

District President Dr. Fegan recommended to the Board to adopt a resolution to Confer title of Emeritus to (Mr. Dan Nesmith – Professor of History), (Dr. Thomas Vance – Professor of Biology), and (Mr. Mark Dillman – Professor of Math).

Motion by Trustee Aldama and second by Trustee Atkeisson to adopt a resolution to Confer title of Emeritus-Professor of Biology to Dr. Thomas Vance.

Motion by Trustee Atkeisson and second by Trustee Aldama to adopt a resolution to Confer title of Emeritus-Professor of Math to Mr. Mark Dillman.

A framed copy of the resolution were presented to each and pictures with each followed.

#### **Board of Trustees Self-Evaluation**

Vice President Marcy Ballew and Dr. Jeanetta Johnson presented the self-evaluation results. Six out of seven responses were received, and no recommendations for further training. After reviewing everything we realized that question 11 needs to be reworded. Question 11 says that the President presides over the Board of Trustees. We recommend that question 11 be revised to say that the Board Chairman presides over the Board. The next time to complete the self-evaluation is in October of year 2024.

### Resolution and Order of Election

Vice President Teresa Thomas presented Resolution and Order of Election materials. Election is coming up in May 2023 and we need to take action and have a record vote on file.

#### Enrollment

Vice President Sina Ruiz presented update on enrollment. This update will be very similar to last month. A quick update as of the census date, the fall second eight weeks remains flat. We started our pre-registration for both winter mini and spring on November 7<sup>th</sup> which is a week late. We are down about 25% in semester credit hours but hope to see a gap this week as students are coming in to register.

### Finance and Operations

John Boswell explained that chapter 3:12 of the tax code requires that if you want to approve new guidelines and criteria you must hold a public hearing before you approve new guidelines and criteria. Chairman Judson called for a public hearing on Navarro College Tax Abatement Guidelines and Criteria.

John Boswell stated that administrative action must be done if in any event over the next 2 years you chose to enter into any type of tax abatement and guidelines and criteria. Once approved the Navarro College Participation in Tax Abatement Programs and Reestablishing Criteria and Guidelines for Granting Tax Abatement (Board Policy CAF) are good for 2 years.

Chairman Judson asked for a motion to approve Navarro College Participation in Tax Abatements Programs and Re-establishing Navarro College Criteria and Guidelines for Granting Tax Abatement (Board Policy CAF).

Motion to approve by Trustee Aldama and second by Trustee Atkeisson. All were in favor, none opposed.

Chairman Judson closed the public hearing and opened the remainder of the Board of Trustee meeting.

Vice President Teresa Thomas presented November 2022 Financial Statements. There were several budget amendments for October 2022 totaling \$3.4 million and are rolling over our grant funds.

For sources of funds, we have received 43% of student income,1.13% of local appropriations, and 17.87% of our overall general educational fund income. We have received 26.77% of our auxiliary fund and are same amounts as same time as last year. In resource allocations we have lowered our expenses by \$5.4 million, but most of the \$5.3 million is due to HEERF funds. Budget to date actuals in the Educational General are down \$5.3 million but in the actuals are the accrual reversals of \$3 million. For the resource allocations we have spent less than we thought and are up \$288,000 just by what was budgeted. We have same contingencies as last month and we have additional tax revenues from values being bigger.
